Synergy Plus Limited Appoints New Chief Executive Officer

Synergy Plus Limited (ASX: SNR) is pleased to advise that Garry Henley has been appointed to the position of Chief Executive Officer ("CEO") effective immediately. Peter Cappendell who assumed the role of acting CEO in August 2009 will continue with the Company in a new role as Chief Operating Officer. This change follows the completion of an internal strategic review and the announcement of the Company's profit of \$1.58m before tax for the first half of this financial year.

Garry brings over 25 years experience in the IT&T system integration sector and was a founder of Alphawest, where he was appointed Managing Director in 1999 and Chief Executive Officer in 2002. He led Alphawest during its sale to Solution 6, a subsequent management buy out and then through its acquisition by Optus/Singtel in 2005, remained CEO until 2008.

Domenic Martino, the chairman for Synergy Plus, stated "we committed to the market that we would wait to ensure we found the right candidate before formally appointing a new CEO. Synergy has made considerable progress during the last six months and we need someone who can continue to drive the panned growth. We are pleased that Peter will be continuing with the Company in a new role as Chief Operating Officer and we thank him for his outstanding contribution as acting CEO over the past 6 months."

Peter Cappendell, who took over as acting CEO in August 2009 said "Garry is an excellent choice and clearly has the right experience to lead Synergy Plus. I will be moving into the role I had originally planned to take prior to stepping in as acting CEO."

During the course of the last six months Synergy Plus changed its name and rebranded following the acquisition of Melbourne based Synergy Plus, acquired the Leading Solutions business and has grown its services business by 23%.

"We embarked on a project to transform the business, leveraging the Synergy Plus enterprise class data centre practice and to build out our services across our eleven operations in Australia," Peter Cappendell said.

Garry's remuneration package comprises a balance of fixed salary of \$312,000 per annum (including statutory superannuation) and performance based incentives to be determined by the Board.
